4. I understand that failure to attend any of the above dates may make me eligible for replacement.

5. I agree to arrive promptly for photo day, all trainings, fittings, rehearsals, and on event day.
6. I, (student models and entertainers) agree to maintain my eligibility to participate in the show by ensuring that my grades do not drop, and I am not subject to any disciplinary action.
7. I agree that to represent Bellarmine in the Fashion Show I must comply with Bellarmine's Code of Integrity. I agree to be a positive representative of Bellarmine and to act in a cooperative and respectful manner at all times while participating in any Fashion Show activities. (e.g. use of appropriate language, appropriate dress, and appropriate behavior)
8. I understand that use by minors or abuse by adults of alcohol, or use of illegal drugs while participating in any activities during or related to the Fashion Show (e.g. rehearsals, training, fittings, etc.) will result in immediate dismissal from the Fashion Show, and if a student, may also result in disciplinary action.
9. I, (student models and entertainers) agree to remain at the SCCC in the assigned SCCC staging rooms during rehearsals on November 15 and 16, 2019, and at any other time will be accompanied by my parent or guardian.
10. I (**mom models**) agree not to get my child a separate hotel room and to accompany them if they are in my own room.
11. I, (**all models and entertainers**) agree to wear the clothing selected for me and not alter them in any way; nor will I alter the hair and make-up styling administered to me on the day of the show and will arrive on show day with hair and make-up prepped as per instructions provided.
12. I, (all models and entertainers) agree to take care and caution with the clothing and accessories, and return all items at the conclusion of the show. I will be held financially responsible for any unreturned items or damages incurred due to negligence (e.g. eating or drinking while wearing the clothing, etc.).
13. To protect the clothes from staining, I agree to NOT use spray tan or tanning lotion within one (1) week of the show. I will be held financially responsible for any damages incurred due to staining from tanning products.
14. I hereby give permission for my name, picture, portrait, photograph, and/or video (in all forms and media and in all manners, including composite) to be used for advertising, for publication of any kind, or any other lawful purposes. I waive any right to inspect or approve finished product, including written copy, which may be created in connection therewith. I waive any rights of compensation or ownership thereto.

I understand that any violation of the conditions above may result in immediate removal from the Fashion Show and, if student, in disciplinary action as needed.
