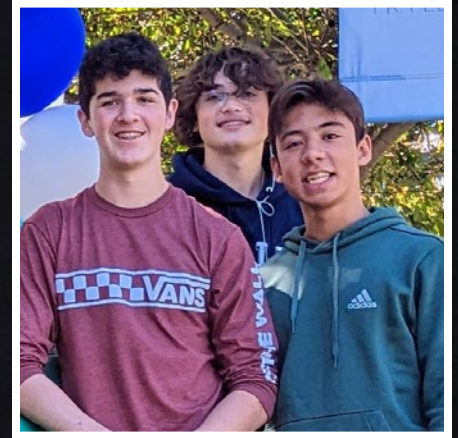

## *Universal Apostolic Preferences*

Released on February 19, 2019, the Jesuit Superior General, Fr. Arturo Sosa, S.J., announced four Universal Apostolic Preferences for the Society of Jesus over the next decade. These were identified through a fruitful process of discernment lasting almost two years. All Jesuits were invited to take part and many representational mission partners. The process concluded with a confirmation from Pope Francis in a special meeting with Fr. Sosa. The Four Preferences are:

1. To show the way to God through the Spiritual Exercises and discernment;
2. To walk with the poor, the outcasts of the world, those whose dignity has been violated, in a mission of reconciliation and justice;
3. To accompany young people in the creation of a hope-filled future;
4. To collaborate in the care of our Common Home.

Last academic year, Bellarmine College Prep's Justice Theme was Care for Our Common Home. This year's Justice Theme is Walking with the Excluded.

## 68th Mothers' Guild Fashion Show For Tuition Assistance

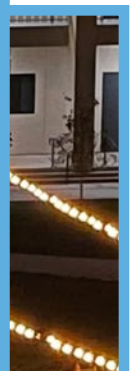
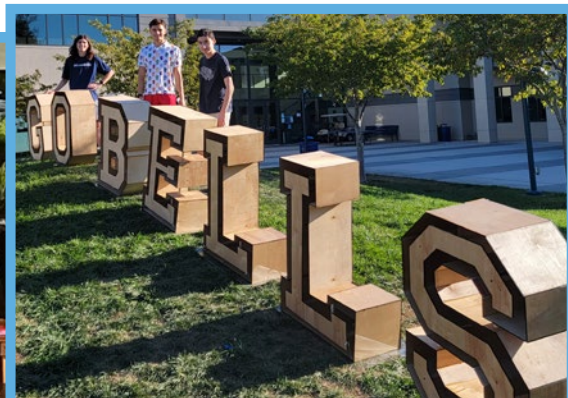
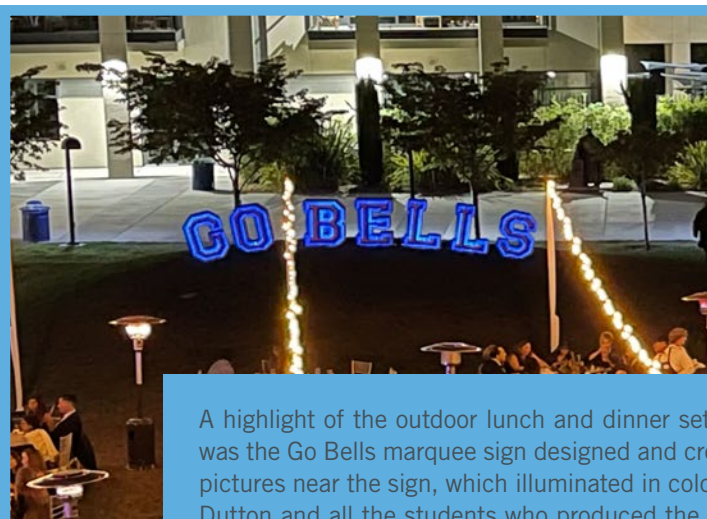
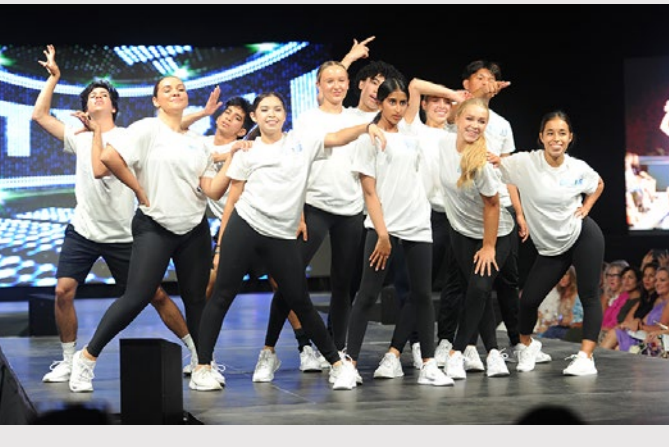

'55 (Public Service); and Rusty Zimmerman '98 (Humanities & Fine Arts) were honored for exemplifying Bellarmine's motto of being men for and with others through their extraordinary personal achievements, remarkable professional accomplishments, and significant contributions to the community.



## Hall of Fame Inductees

**Vic Giacalone**, president and CEO of The Best Electrical Company, Inc., has managed his family business for the past 54 years after graduating from Santa Clara University. He has established a reputation in the San Jose area for building and maintaining longstanding client relationships and a tremendous depth of knowledge in his field. Vic has been involved in numerous professional organizations and committees in his career, including as president of the National Electrical Contractors' Association from 1981-83. He has also been committed to civic involvement as a member of the Rotary Club of San Jose, Civic Center Kiwanis Club, and Committee to Improve the Economic Climate of San Jose, as well as a board member at the San Jose Historical Museum and San Jose Repertory Theatre. He is currently a member of the Loaves and Fishes Advisory Board, the San Jose Chamber of Commerce Housing and Homelessness Working Group, the Guadalupe River Park Conservancy Homeless Advocacy Committee, and the Western Association Board of Directors for the Order of Malta, a Catholic service organization. In 2012, Vic was named Distinguished Citizen of the Year by the Boy Scouts of America, and in 2010 he was honored by Bellarmine as the President's Award recipient. He is the longest-tenured member of Bellarmine's Alumni Council, serving as president for eight years and chair of the Christian Service Committee since 2004.

Throughout the school's long history, it is likely that no individual has given more of himself to Bellarmine, and the people of Bellarmine, than **Rev. Gerald T. Wade, S.J.** As a student, he rarely missed an event or activity, embracing the sense of brotherhood the school provided. And more

than 70 years later, he continues to embody that spirit of community through his constant warmth and kindness. Inspired by the enthusiasm and camaraderie of the Jesuit Scholastics who taught him, he entered the Society of Jesus upon graduating from Bellarmine in 1955. He completed undergraduate studies and earned a master's degree in Philosophy from Gonzaga University before returning to Bellarmine in 1962 to teach Latin, run the senior dorm, and moderate the Cardinal newspaper. Fr. Wade was ordained to the Priesthood on June 1, 1968. He went on to complete a master's degree in Theology at Santa Clara University and a Master's in Latin at the University of Southern California, then became vice principal of Loyola High School in Los Angeles. After serving there for five years, he was missioned to be president of Jesuit High School in Sacramento. After four years there, Fr. Wade came back to Bellarmine once again in 1979, this time for good. He served as the school's 14th and longest-tenured president, overseeing a period of tremendous development that included the modernization and expansion of the campus, advancement of the school's endowment and Tuition Assistance Fund, and expansion of academic and co-curricular programs. His leadership helped the school continually adapt to the shifting landscape of contemporary Silicon Valley, while adhering to the core Jesuit values that have distinguished Bellarmine since the days when the campus was surrounded by tree orchards. Fr. Wade received honorary Doctorate degrees from the University of San Francisco in 2015 and Santa Clara University in 2019, and he now serves as Bellarmine's chancellor. Aided by his legendary ability to remember every person he meets and

make them feel welcome, he continues to maintain relationships with countless members of the Bellarmine community over multiple generations.

The artistic talent of **Rusty Zimmerman** blossomed at California College of the Arts and led him to Brooklyn, New York to pursue a career as a professional painter. Rusty has served as a portrait artist for former New York City Mayor Andrew Cuomo, and his work has been featured in publications such as the New York Times, Bloomberg Citylab, and Saatchi Gallery Magazine in London. He has also lectured at Wellesley College and Long Island University. In 2015, uncomfortable with the fact that the art of portraiture was inaccessible to many due to financial constraints, Rusty founded The Free Portrait Project. Over the next two years, he completed 200 free portraits of his neighbors – painting everyone from schoolteachers to street performers, software engineers to unhoused individuals, Haitian immigrants to Hassidic Jews, college students to retirees – attempting to capture the tremendous diversity of his neighborhood of Crown Heights and use his art to break down religious, ethnic, and socioeconomic barriers in his community. Accompanying each portrait was a recorded interview with the subject, which the Brooklyn Historical Society preserved as an oral history of Crown Heights and the people who live there. The portraits have been exhibited at the Brooklyn Museum, Brooklyn Children's Museum, and Brooklyn Borough Hall, and there is a permanent collection at Poster House NYC.

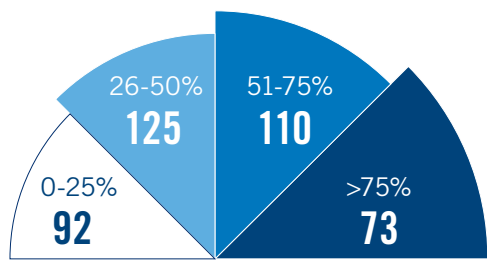

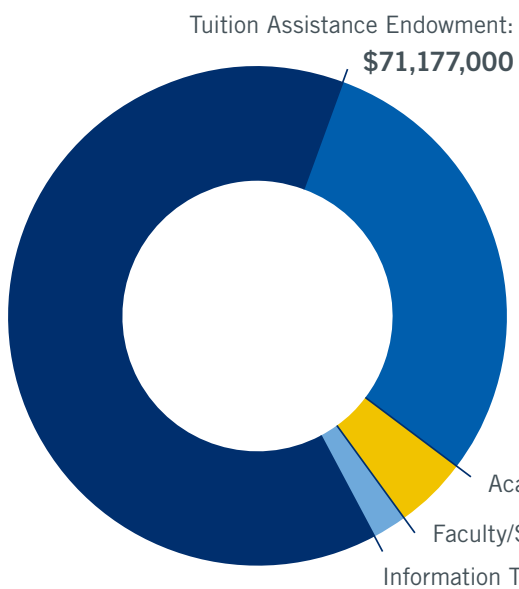
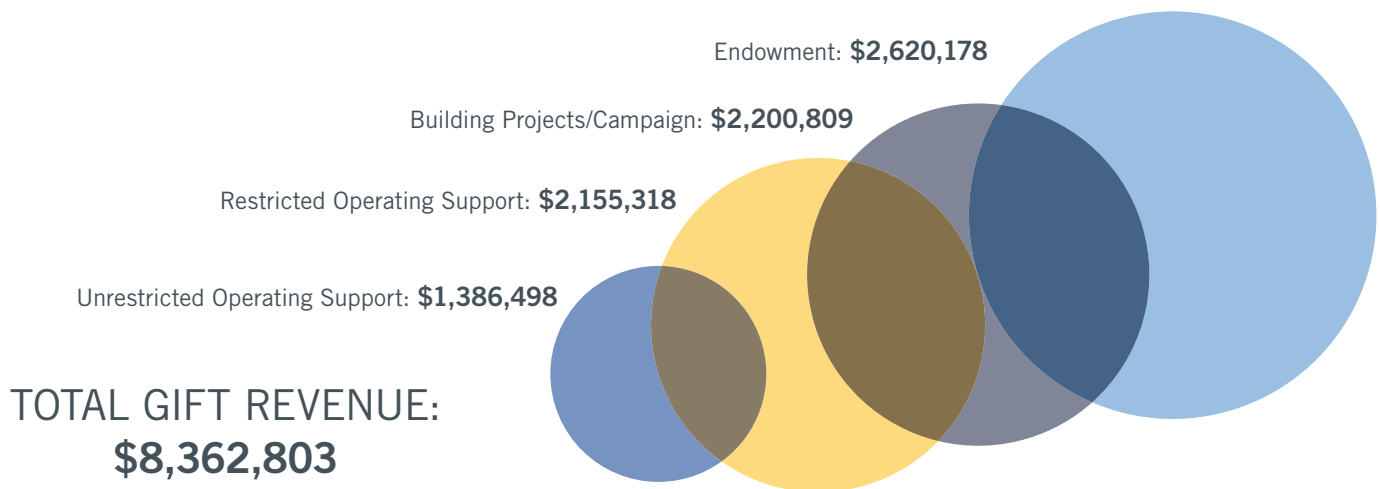

## TUITION ASSISTANCE 2021-2022

Bellarmine's Tuition Assistance Program is vital to maintaining the school's diversity, as well as ensuring that all qualified candidates may enroll and continue their studies at Bellarmine, regardless of their financial circumstances. During the 2021-2022 school year, Bellarmine awarded \$5.185 million in tuition assistance to nearly one quarter of our students. The funds needed to provide such unparalleled support are the result of contributions to the Direct Tuition Assistance Fund, and partially from the Tuition Assistance Endowment. The adjacent graphic depicts how these funds were awarded, based on a percentage of tuition covered. Tuition for the 2021-2022 school year was \$23,980

## TOTAL ENDOWMENT FUNDS: \$111,324,000

Bellarmine received gifts from alumni, students, parents, grandparents, parents of alumni, friends, businesses, and foundations during the 2021-2022 fiscal year. These gifts helped fund day-to-day costs of operating the school, as well as programs and initiatives. In addition, donors contributed to Bellarmine's Endowment, helping it reach a market value of \$111.3 million as of June 30, 2022.

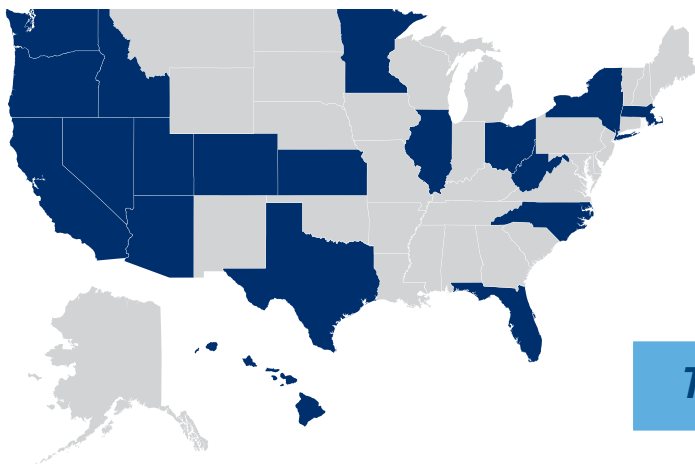
**TOTAL AMOUNT RAISED**

## *Meet Carolyn Fu*

On just about any weekday morning at Bellarmine, one is likely to encounter Carolyn Fu hard at work helping to keep the campus aesthetically pleasing and environmentally sustainable. Carolyn and her talented landscape co-workers are instrumental in maintaining the school grounds, despite the challenges of California's drought conditions and the multiple uses of the campus in general and for special events.

Below is a recent Q&A session with Carolyn for this publication, which we hope provides some insight into one of many of our dedicated employees.

*Q. A little background, please: where were you born and raised? When and how did you develop your interest in landscaping/gardening/the environment?*

A. I was born in Dallas, Texas, but we moved to the Bay Area when I was four. After growing up here, I moved away as an adult. It wasn't until I lived in Oregon and was well into adulthood that I got bitten by the gardening bug. After gardening there for a few years, I decided to go back to school to study horticulture to make a career out of it and to learn how to be a better gardener. Nature is where I feel the presence of God most strongly. When I was at U.C. Davis, I would wander down the quiet country roads as a break from studying. I found God in a random wildflower growing on the side of a field and in the clouds in the blue sky. This revelation profoundly affected me.

*Q. Please tell us a bit about your position at Bellarmine.*

A. I've been working as a gardener at Bellarmine for almost 3-½ years. Activities range from hand watering (areas without irrigation), deadheading, weeding, pruning, planting, fertilizing, minor irrigation maintenance, lawn care, mulching, and cleanup. The work is year-round in the Bay Area because we have such a short dormant season.

*Q. What do you enjoy most about your job and what are the current challenges?*

A. I really love working with the plants. They are complex, diverse, beautiful, and mysterious. When you see a tree, isn't it amazing to think that they can grow from a tiny seed using only air, water, sunlight, and some additional element nutrients? Some of my favorite activities are plant propagation, which I do mostly at home due to the intensity of care required, digging and amending soil, planting, deadheading, and mulching. Bellarmine's supportive community is also a big reason I enjoy working here—we have amazing Jesuits,

administration, faculty, staff, and students. In my experience, Bellarmine's workplace culture is one that is rare today. One major challenge in organic management is that it is more time and labor intensive than conventional management, especially with weed control. Irrigation has also been a challenge for a variety of reasons.

*Q. I understand that you are taking some college courses.*

A. It has been a long and slow journey, but I'll be graduating in December from Oregon State University with a B.S. in General Horticulture. Like many others who go back to school in midlife, I have found it to be challenging in different ways this time around, but it has also been an enormous blessing.

*Q. You work with a great grounds crew team. What would you like to say about those with whom you work?*

A. They are a great team! I can't say enough about them. They have been such a pleasure to work with. They are inspiring, humorous, kind, helpful, skillful, and knowledgeable—genuinely good people who want to do a good job. I am also extremely grateful to management for giving me many opportunities to expand my horticultural horizons.

*Q. What position(s) did you have prior to coming to Bellarmine?*

A. I've worked many different jobs at different times in my life — retail, food service, caregiving, mental health services, and healthcare. It would be ideal to have a job doing what you love, and I have found that in horticulture. I cannot imagine working in any other field. Prior to Bellarmine, I worked in a retail nursery. Before horticulture, I worked for 11 years as a medical assistant in allergy/immunology and internal medicine.

*Q. You are instrumental in Bellarmine's green initiatives as we strive to "care for our*

*common home." Please share some thoughts on the significance of environmental sustainability here at Bellarmine.*

A. I feel privileged to work for an organization that sets sustainability as a major priority, and organic management was a major reason I applied for this job. Although horticulture is considered part of the "green industry," we are learning that there are many aspects about it that are not "green" in terms of environmental friendliness. In the past, school campuses and landscapes have for the most part been structured and maintained in ways that favor expediency and convenience at the expense of ecology and the environment. It's exciting to me that school campuses can be places where more sustainable practices can be explored and enacted. However, organic management is only one small part of the solution, and it has benefits and drawbacks. As we make changes towards greater sustainability, some changes can be difficult to accept at first. The new normal will probably be quite different from that of the recent past, yet I think we are becoming more aware of the urgent need for change in the face of climate change, degradation of natural resources, mass species extinctions, and collapse of ecosystems.

*Q. Do you have a personal philosophy about how you approach your work at Bellarmine?*

A. My philosophy is pretty simple, because I'm a pretty simple person. Some tenets which guide me include always trying my best, continually learning, being honest, and loving my neighbor as myself. It's still a work in progress, especially with the last one. My dream for Bellarmine is that it be a place where people can derive joy, peace, learning, and inspiration from connecting with nature, even in a contrived landscape. I hope we can achieve this in a way that is mindful of the greater society and environment.

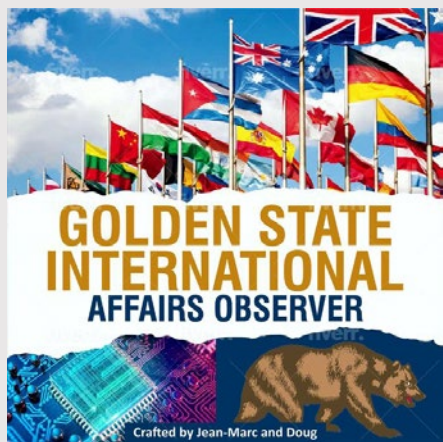

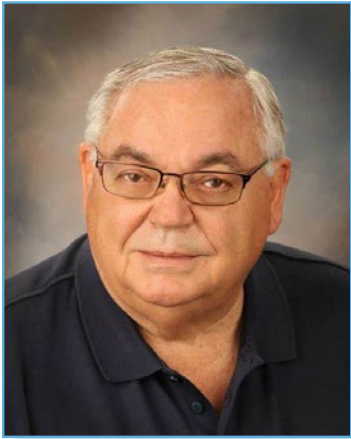

# *In Memoriam*



***Fred T. Franzia '61*** (May 24, 1943 – September 13, 2022). Fred was a well-respected wine industry leader who, in 1973, founded Bronco Wine Company with his brother Joseph S. Franzia '60 and his cousin John. As noted in Fred's obituary, "Core to his vision was a belief that wine should be enjoyed and consumed on every American table ... His entrepreneurial spirit, tireless dedication, and his commitment to both his family and to the Bronco family will forever be remembered. His legacy will endure for generations to come." Among Fred's surviving relatives are his five children Renata, Roma, Joseph, Carlo, and Giovanna; fourteen grandchildren; his brother, Joseph S. '60; and his sisters, Joellen D'Ercole and Catherine McFadden.

***Lorry I. Lokey*** (March 27, 1927 – October 1, 2022). Lorry was an astute businessman and generous philanthropist whose kindness included having made the single largest contribution by an individual to Bellarmine College Prep. In 2010, Lorry joined the Giving Pledge, committing to donating 99% of his wealth. He established the Lorry I. Lokey Research School for Biochemical Science in 2007, and the Lorry I. Lokey Preclinical Research Facility in 2011, both at the Weizmann Institute of Science. Lorry, who launched *Business Wire* in 1961, began his journalistic career at Stanford University and in the United States Army. In 2006, Lorry sold *Business Wire* to Berkshire Hathaway. In addition to his remarkable support of Bellarmine, Lorry was also a benefactor of numerous educational institutions, including Stanford, the University of Oregon, Mills College, and Portland State University, to name a few.



***Joseph P. Melehan '71*** (August 18, 1953 – September 5, 2022). Joe was married to his beloved wife, Celeste Martin Melehan (former Bellarmine Mothers' Guild Fashion Show chair) for more than 43 years. ## *Benefit Your Heirs and Bellarmine Using Your Retirement Account*

You can always use your Individual Retirement Accounts 401(k)s, 403(b)s, or other retirement accounts to make a charitable contribution by cashing out some of the proceeds and donating them to the charity of your choice (say, Bellarmine College Prep, for example). However, there is not a substantial tax benefit to doing so. On the other hand, if you name a charity such as Bellarmine as the beneficiary of your retirement assets as part of an estate planning strategy, you and your heirs can take advantage of some tax benefits. This charitable donation of retirement accounts can minimize the amount of income taxes imposed on your heirs and your estate if done properly.

Except for a qualified charitable distribution (feel free to ask us about this nifty gift planning method), benefits paid from a retirement plan are taxable as ordinary income to the person receiving them whether this is the original account holder or an individual beneficiary of an account holder. Unlike other estate gifts, distributions from inherited retirement plans are taxable as ordinary income to the person who receives them.

However, when you name Bellarmine as a beneficiary to receive your IRA or other retirement assets upon your death, you create several benefits: neither you nor your heirs will pay income taxes on the distributions of the assets; your estate may receive a tax deduction for the charitable contribution; the full amount of your retirement account will directly benefit the charity of your choice since charities do not pay income tax; and you get to achieve your philanthropic goals and ensure your legacy.

Since many estates are valued under the amount subject to the estate tax, you can focus on minimizing the income tax consequences your heirs may be subject to depending on the assets you leave them. If you leave an IRA or

401(k) to your heirs, they will have taxable withdrawals and may have to empty the asset within ten years thereby ending its tax-free growth. So, reconfiguring gifts to your heirs may help relieve any tax burdens they may face.

For example, donating retirement assets to a charity and giving your heirs appreciated property such as stocks or real estate aids your heirs since that appreciated property would receive a step-up in tax basis and thereby eliminate or reduce the capital gains tax on those assets upon their sale. Doing so thus leaves more of a legacy for your heirs.

Making a charity the beneficiary of your retirement accounts is straightforward and provides you with flexibility. Typically, you can complete a form through your employer or the administrator of your plan indicating you would like a charity such as Bellarmine to receive that asset upon your passing. As completion of these forms does not take up a lot of time, you can adjust beneficiaries or percentages they are to receive almost any time. The other nice thing about these beneficiary designations is that they allow the asset to pass outside of probate or trust administration allowing your gift to accrue to Bellarmine more rapidly so that we can put your gift to work educating and forming the young men on our campus.

As retirement accounts often involve the rights of spouses, make sure you check with your estate planning lawyer to ensure that all involved are on board with this legacy gift. Of course, you will want to check with your tax professional as well to check that such a plan accomplishes the goals you want relative to your tax situation.

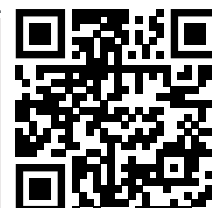

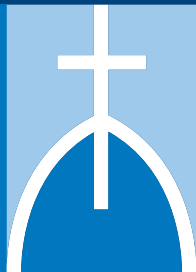
